#### Northern Marianas

The Commonwealth of the Northern Mariana Islands (CNMI) is an insular area and commonwealth of the United States consisting of 14 islands in the northwestern Pacific Ocean. The CNMI includes the 14 northernmost islands in the Mariana Archipelago except the southernmost island of the chain, Guam, which is a separate U.S. territory.

The CNMI's main economy is from tourists arriving from Asia. Previously, travelers from Japan were in abundance to our islands. But over the years and with the recent pull out of Delta Air Lines, tourists from China and Korea have increased to provide our economy with some sense of stability.

#### Who We Are:

The Commonwealth Ports Authority (CPA) was established by CNMI Public Law 2-48 on October 8, 1981. CPA is responsible for three airports and three seaports on the islands of Saipan, Tinian and Rota. The Island of Pagan also has an airstrip but it is currently unavailable for air travel.

CPA is overseen by a seven member Board of Directors appointed by the CNMI Governor and confirmed by the Senate. The Board of Directors hires an Executive and Deputy Director, who in turn hire their respective port managers, supervisors and employees.

The CPA Administration Office is located on the 2nd floor of the Arrival Terminal at the Francisco C. Ada/Saipan International Airport. There are a total of four port managers, a number of department specific managers and supervisors and approximately 200 employees on all three islands.



The Master Plan for the Tinian International Airport has been completed, the Saipan Airport Master Plan will be completed by end of 2020 and the and Rota Airport Master Plans will be completed by the end of this year.

## MAJOR ACCOMPLISHMENT



On November 9, 2018, the Commonwealth Ports Authority and the United States of America entered into a purchase agreement for the lease of the property on Tinian should certain preconditions listed within the purchase agreement be completed. This purchase agreement granted the United States of America the right of immediate occupancy of the Leased Premises and Easement Areas for the purposes of all inspections, permits, and surveys. As a result of such inspections and surveys, it was determined that amendments to the Lease, including its attachments, were required, and the parties discussed and subsequently agreed to such amendments.

On May 3, 2019, CPA executed a 40-year lease agreement with the United States of America for land in Tinian for \$21,900,000. The purpose of this lease agreement is to provide the United States of America land to construct the necessary facilities and infrastructure it requires to achieve Divert Airfield capabilities for the U.S. Department of Defense. These facilities and infrastructure are intended to be constructed largely on the north side of the Tinian International Airport runway and at the Port of Tinian.

## **FINANCIAL OUTLOOK**

The Commonwealth Ports Authority is an autonomous agency that generates revenues from port users to fund operating expenses, capital projects, and debt service requirements. The CPA also receives federal grants from the Federal Aviation Administration (FAA), Department of Homeland Security (DHS), and the Department of Interior (DOI) to fund improvements throughout the ports.






