



# **Looking Forward**

The COVID 19 Pandemic:In its role as Mass Care lead for the CNMI, the DCCA stepped up to man and assist with the management of the CNMI's quarantine sites at the Kanoa Resort, Pacific Island's Club, and the Marianas Resort. The DCCA also participated in the Distribution of food to home-quarantined residents. The DCCA sustained significant budgetary cuts due to the pandemic-driven economy. Originally furloughing 37 staff, the DCCA has been able to see the return of all but five of the furloughed staff.

**CCAC NEA Funding:** After regaining eligibility for federal funding in 2019, the CCAC secured \$285,000 from the National Endowment for the Arts for Federal FY2021.

**HPO Disaster Grant Funding:** The HPO is looking to develop and improve historic sites on Saipan, Tinian, and Rota through a multi-million dollar disaster-recovery grant in late 2019 and 2020.

Decrease in NAP Benefits: The NAP reduced income eligibility and benefits by 25% at the start of the new fiscal year due to the lack of additional funding from the US Congress. The NAP will need to reduce benefits another 25% in April of 2021, unless additional Congressional funding is secured.

Marianas Motocross Park: The DCCA entered into a partnership with the Marianas Racing Association to see the revival of motocross in the CNMI with the Marianas Motocross Park.

Renovated Youth Centers: The DYS recently re-opened the completely renovated Kagman Community Center and will be completing the renovations of the Tanapag Youth Center over the calendar year.

Consolidation of DCCA Offices: To cut down on costs (utilities, rental, maintenance), many of the DCCA offices have been consolidated.

More Child Care Available: The CCDF saw its federal funding doubled in FY19. Following a recent capacity survey, the program has provided child care assistance to a significant increased number of families.

# **Challenges**

Coming in to the new fiscal year, the DCCA was still working towards recovery from super typhoon Yutu, and at the same time assisting recovery efforts through the assignment of staff to recovery functions. As we were coming off of "Yutu recovery", the CNMI was struck by the COVID pandemic, and the DCCA was back in its "disaster mode", as the lead on Mass Care functions for the CNMI. DCCA staff stepped up to manage and man quarantine sites, which they still do, alongside DFEMS and other assisting agencies, to this day. DCCA resources suffered a serious blow due to the effects of the pandemic on the economy and reduction in resources. To

address this, many employees were transferred to federal funding sources, five employees remain furloughed, and offices were consolidated to save on costs.
