CAROLINIAN AFFAIRS OFFICE

Pursuant to Article III, Section 18 of the CNMI Constitution, the Carolinian Affairs Office (CAO) shall:

- Advise the governor on matters affecting persons of Carolinian descent within the Commonwealth.
- Review the application of government policies and the availability and quality of government services for persons of Carolinian descent
- Investigate complaints and conduct public hearings regarding matters affecting persons of Carolinian descent
- May recommend items for inclusion in the proposed annual budget, review the budget before its submission by the governor to the legislature and recommend amendments to the budget relating to matters affecting persons of Carolinian descent.
- May at any time require information in writing or otherwise with respect to matters affecting persons of
- Carolinian descent from the officers of any administrative department, office or agency of the Commonwealth.
- CAO is represented as a member of the Governor's Council created under Article VI, Section 5 of the CNMI Constitution.
- Our mission includes providing educational, social and cultural programs and services to our community.

WHAT DID FY 2022 LOOK LIKE?

In FY 2022, the Carolinian Affairs Office assisted more than 1500 individuals, despite the continuing threat of the global health pandemic. These individuals were assisted with their application for the local Economic Impact Payment (LEIP), inquiries and follow ups on their Pandemic Unemployment Assistance (PUA) submitted to Department of Labor, applications for the Fisheries Program, Low Income Home Energy Assistance Program, and other benefits available to those victimized during the pandemic. HAFA ADAI TIROW EXPERIENCE: Launching of the Hafa Adai Tirow Experience on Tuesdays & Thursdays



CHALLENGES OF FY 2022

UNDER STAFF : The Carolinian Affairs Office have been under staffed for years. Funding made available through ARPA made it possible for the CAO to employee new personnel for its programs & services. Request for Civil Service FTE's for permanent placement.

COMMUNICATION : A key factor in moving projects forward, communication between the CAO and other departments have not been as successful as we would like it to be. For this reason, it has caused delays in projects such as the renovation of the CAO.

DATA QUALITY : Despite its availability, data is not being used effectively as it is inaccurate and inconsistent.

MOVING FORWARD

Appreciating the intent and purpose of the Carolinian Affairs Office will continue positioning its mission, vision and goals at the forefront of its mandate which will only lead to the betterment of the Carolinian community.
