These issues include the protection of children from abuse and neglect, preservation of the environment, protecting the Commonwealth's financial assets, the protection of consumers, and public safety.

WHO WE ARE

The Office of the Attorney General (OAG) is constitutionally created pursuant to the NMI Constitution, ART. 11I, § 11, as an independent agency within the Executive Branch. The Office of the Attorney General is headed by an Attorney General elected to a four-year term. The Attorney General is the Chief Legal Officer of the Commonwealth Government and is responsible for:

- Providing legal advice to the Governor and Executive
 Departments including public corporations and autonomous agencies;
 - Representing the Commonwealth in all legal matters and;
 - Prosecuting violations of commonwealth law.

HIGHLIGHTS & ACCOMPLISHMENTS:

ACTIVITIES:

- Guilty verdict on all nine counts in sexual assault jury trial CR 21-0072-CE Commonwealth v. Kaipat.
- ❖ Attributed to the ruling in *Commonwealth v. Kaipat*, 2022 MP 9, where the Supreme Court reversed the lower court's decision to suppress DNA evidence collected in a warrantless search.

United States Supreme Court cases:

Supported as amicus two cases in the United States Supreme Court:

- *United States v. Rahimi* (22-915) which seeks to limit access to guns for those under domestic violence protection orders.
- Rudisill v. Mcdonough (22-888) which seeks to allow veterans to utilize both the Montgomery and 9/11 GI benefits.
- Submitted comments in support of H.B. No. 22-39, HS1 To amend Title 6, Division 6, Chapter 5. Witnesses, by adding a new section 6503. Witness to Outcry of Abuse; and for other purposes, which was signed into law on January 31, 2023.
- Submitted comments in support of the proposed legislation H.B. 22-35, HD1, entitled: "To add a provision to prohibit convicted felons from possessing firearms and/or ammunition; and for other purposes."

Proposed Legislation: drafted and updated proposed legislation for the following:

- Numerous Criminal Laws including a contraband bill, child outcry bill, protection of abused children bill, failure to appear bill, possession of firearm by a felon bill, and a habeas corpus bill.
- ❖ Won an appeal before the U.S. Court of Appeals for the Ninth Circuit resulting in reversal of the district court's order enjoining the Commonwealth Casino Commission from acting on the complaint seeking revocation of the Imperial Pacific International (CNMI) LLC ("IPI") exclusive casino license and compelling the Commission to participate in arbitration.
- ❖ Obtained a judgment from the NMI Supreme Court upholding the Commonwealth Casino Commission's suspension of IPI's exclusive casino license for non-payment of its casino regulatory fee and non-compliance with other Commission orders.

The Anti-Corruption Task Force consisting of the Office of the Attorney General, the Department of Public Safety and the Office of the Public Auditor and headed by Special Prosecutor James Kingsman was established on May of 2023.
