In 2009, Public Law 16-48 created the Office of Grants Management. The law was amended in 2016 under Public Law 19-49 to provide more oversight and responsibilities over federal grant assistance in the CNMI government. The repurposed office was renamed the CNMI Office of Grants Management & State Clearinghouse and assumed the following responsibilities -

The CNMI Office of Grants Management & State Clearinghouse (OGM-SC) was established to allow the CNMI government, its elected officials and all agencies to assemble and engage in dialogue with regards to federal aid programs, grants, loans, contracts, contributions, appropriations, advances, direct federal development, and other federal funding sources for the CNMI.

The CNMI Office of Grants Management & State Clearinghouse holds the scope of influence for all federal programs and aid that have direct and indirect effect on the CNMI as stated in *Public Law* 19-49 and in relation to *Presidential Executive Order* 12372.

- a. administer the initiation, coordination and review process of all governmental activities within the government of the CNMI involving federal assistance;
- ensure that federal grant proposals are in accordance with plans, policies, programs, objectives, and procedures of the government of the CNMI. A stamp of approval shall signify concurrence from the OGM-SC;
- c. ensure that proposed government projects for which federal financial assistance is sought are fiscally and environmentally sound and are in compliance with all applicable Federal laws;
- d. ensure that the government of the CNMI complies with all applicable federal laws relating to federal financial assistance and that there exists sound tracking, management, and financial accountability for all federal programs awarded to the government of the CNMI;
- e. perform cost analysis on all federal aid programs, grants, loans, contracts, contributions, advances, direct federal development or other federal funding for the financial impact on the government of the CNMI'S general fund or special funds used to fund the local matching requirement as pre-scribed by federal law;
- f. conduct activities for the acquisition of federal grants and when possible, coordinate to full extent the activities and objectives of an approved grant award. This office will also have the capacity to award sub-grants; and
- g. conduct activities directly related to indirect cost associated with federal assistance.

Since FY2020. the Office Management & State Clearinghouse received an annual budget allocation of \$1.00 from the CNMI Legislature for Personnel and all others, leaving the office completely funded by federal reimbursements through Indirect The OGM-SC is one of only a few Cost. offices in the CNMI Government to be completely self-sufficient non-locally funded.

Section 5 of Public Law 19-49 states that the OGM-SC will be receiving forty percent (40%) of the total Indirect Cost collected and shall decrease by one percent (1%) each fiscal year thereafter until the percentage reaches thirtyfive percent (35%). In addition, the public law also authorizes the OGM-SC to utilize twenty percent (20%) of the total Indirect Cost collection for subgrant awards. In FY2023, the OGM-SC awarded \$65,000.00 in subgrant funding assistance.

CNMI Solar For All

The Inflation Reduction Act authorized the U.S. Environmental Protection Agency (EPA) to implement the Greenhouse Gas Reduction Fund (GGRF), a historic \$27 billion investment to combat the climate crisis. Solar for All was designed to spur the deployment of residential distributed solar energy to lower energy bills and catalyze transformation in markets serving low-income and disadvantaged communities. Solar for All will tackle the financial and non-financial barriers that limit the ability of low-income and disadvantaged communities across the country to benefit from the rapid growth in distributed solar capacity.
