

## Areas of Focus for 2025

Agricultural exports have been on the rise, as shown in the table below. To ensure that the
quality standards for export are worthy of Rota's great history as an exporter, the Division
of Customs Biosecurity has invested in the implementation of its Quality Control Program
where permits are issued. We will be certifying Biosecurity Inspectors in the next few
months and a facility for inspection will be located at Aquaponics office in Sinapalo by
December of this year. We are also looking forward to hiring of new Inspectors by FY2026.

- A new installation of the Maritime Unit for the Division of Customs Biosecurity will unveil by the end of the FY25 for Stop and Board of vessel inspections.
- New K9 unit will be in full operations by FY26.
- Focus and infuse more training and professional development to increase employee satisfaction and improve morale.
- Production of our five (5) year of data publication will be completed by October 2025 and published by January 2026.

# **Challenges and Solutions**

- Austerity measures has made cuts to the department budget to return accounts to fiscally responsible levels. Despite that fact, operations and services still continue at the same level of standard. Investment in grant writing has become one of the priorities of the department moving forward.
- Closing the fiscal year within budget has been challenging because of the cuts to ongoing operations and employee benefits. FY25 needs to be realistic to fund essential operations and required personnel obligations. It impacts morale, retention and production levels.
- With cuts to Personnel budgets, we are experiencing a new level of turnovers and resignations.
   Personnel are leaving Rota to seek work in the U.S. Mainland. Finance has been preparing for such situations since Covid-19 Pandemic to address absenteeism due to Covid measures and sick leave. All staff are cross trained to perform the operational related duties between positions without compromising integrity of operations and with audit points in place.
- Finance has had to relocate twice in FY24 due to cuts in Operational budgets. This has caused
  issues with our cybersecurity and access to our Financial Management Systems. We are anticipating a permanent location at the Superior Courthouse by December 2024 to address these
  issues.
- Export Quality Control Program by Customs Biosecurity was implemented to address poor quality of agricultural products from Rota.
- FY21 Office of Public Auditor conducted an audit on our department's operations that resulted
  in four audit findings as indicated in Report No. 21-06 Audit of Cash on Tinian and Rota in December of 2021 and August 04, 2023, No. 23-02 Audit of Collection. Issues have been resolved
  and policies have been created for efficiency.

# Reflection

Fiscal accountability and operational accountability became the two virtues we had to stand on to make it through Fiscal Year 2024. Being resilient has always been a part of our culture, and we pushed the envelope of how much the employees of this great department invests into public service by ensuring that we maintained the same level of services regardless of our budgetary constraints.

Moving forward with progress, economic infusion, and development can be expected from the increase in interisland and international flights, completion timetables of Capitol Improvement Projects, increase in foreign investments interest, and re-establishing relationships with Japan and South Korea.
